TEXAS PREPAID HIGHER EDUCATION TUITION PROGRAM CHANGE OF BENEFICIARY

You may change the beneficiary as long as you meet the following criteria:

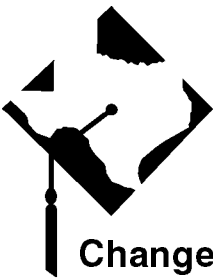
- The original beneficiary has not used any contract benefits.
- The new beneficiary is a member of the beneficiary's family and meets residency requirements (**see "Ways to prove Texas residency for the new beneficiary" below**).
- The new beneficiary is younger than 18 years of age and has not graduated from high school or 18 years of age or older and enrolled in high school at the time of the change request.
- The new beneficiary cannot have more than five years of combined TGTP contract benefits.

Ways to prove Texas residency for the new beneficiary:

- Less than one year old: birth certificate
- Ages 1-5: documentation from a child care center or provider that reflects 12 months of continuous residency, or a written statement from a parent or guardian that care is provided in the home.
- Grades K-12: report card, progress report, or transcript issued within the past 12 months.

When completing the form, please ensure the Certification of Current Purchaser and Joint Purchaser (*if applicable*) section is completed in the presence of a Notary Public. Your payment of \$50 payable to the Texas Guaranteed Tuition Plan must accompany the completed form or it will not be processed.
