

Petition Protesting Property Value Study Findings

The petitioner identified below protests the Property Value Study findings for its district or property, pursuant to Government Code Section 403.303 and 34 Texas Administrative Code Sections 9.4301-9.4317.

The petitioner submits this petition in three parts – Parts A, B and C. Part A identifies the petitioner, states the total value the petitioner claims is correct, and contains the required signatures and attestations for the protest.
