The notarized signatures of both the purchaser and joint purchaser, if applicable, are required to cancel a plan contract. Once a signed cancellation request bearing all required signatures is received, the contract will be cancelled and refunded within four to six weeks. Purchasers who cancel their contract before the beneficiary is 18 years old or has graduated high school will not receive earnings.
