The amount of the refunded distribution that is properly recontributed to your Texas Guaranteed Tuition Plan account will not be included in gross income for federal tax purposes; however, the original distribution will still be reported on your 1099-Q tax form. Please consult a tax advisor to ensure the recontribution is reported correctly on your tax return.
2. Recontributed amounts cannot exceed the amount of the refund.
