Mentor Protégé Program

The purpose of the Mentor-Protégé Program is to foster long-term relationships between prime contractors and Historically Underutilized Businesses (HUB) and provide professional guidance and support to the protégé to facilitate their development and business capacity with the intent to increase the ability of the HUBs to contract directly or indirectly through subcontracting with the state of Texas.

Mentor Protégé Program

- The objective of the Mentor Protégé Program is to provide professional guidance and support to the protégé (HUB) in order to facilitate their growth and development and increase HUB contracts and subcontracts with the State of Texas.

Mentor Protégé Program

The Mentor-Protégé relationship is mutually beneficial since mentors can use their protégés to fulfill HUB subcontracting requirements when bidding on state contracts with expected values of \$100,000 or more.

It is advantageous to build a partnership prior to a solicitation or contract award to establish confidence in performance.

 - *Ask how they match prospective mentors and protégés.

Mentor Protégé Program

Volunteer Program between mentor and protégé –
Goodwill for both

Participation in the program must be voluntary for
both the contractor and the HUB

*HUBs need to outreach out and find prime
contractors who may serve as a mentor
