

**AMENDMENT NO. 1
TO THE
CONTRACT FOR ONLINE HUB REGISTRATION AND PROFILE MANAGEMENT SYSTEM
LICENSED SOFTWARE AND RELATED SERVICES
BETWEEN
TEXAS COMPTROLLER OF PUBLIC ACCOUNTS
AND
ASKREPLY, INC./DBA B2GNOW**

This Amendment No. 1 (“Amendment No. 1”) to the Contract for Online HUB Registration and Profile Management System Licensed Software and Related Services (“Contract”) is entered into by and between the Texas Comptroller of Public Accounts (“CPA”) and AskReply, Inc./dba B2Gnow (“Contractor”). For purposes of this Amendment No. 1, CPA and Contractor are sometimes collectively referred to as “the Parties” or individually as “a Party.”

I. Recitals

Whereas, the Parties entered into the Contract effective August 21, 2020; and

Whereas, the Parties desire to amend the Contract’s initial term end date from August 12, 2021 to August 31, 2021 to correct an admirative error.

Now, therefore, the Parties hereby agree to the following:

II. Terms and Conditions

Section 5.1 of the Contract is hereby deleted in its entirety and replaced with the following:

“The initial term of this Contract shall commence on the date of the last signature below (the Effective Date”) and shall continue until August 31, 2021. CPA may in its sole discretion exercise the option to extend the contract for up to three (3) additional twelve (12) month periods. To exercise the option to extend the term, CPA will provide written notice to Contractor; such notice may be by purchase order issuance.”

III. Merger; Order of Precedence

This Amendment No. 1 represents the entire agreement between all Parties hereto concerning the subject matter of this Amendment No. 1 and supersedes any and all prior or contemporaneous oral or written statements, agreements, correspondence, quotations and negotiations. All other terms and conditions of the Contract, not specifically modified herein, shall remain in full force and effect. In the event of a conflict among the provisions, the order of precedence shall be this Amendment No. 1, then the Contract.

IV. Signatories

IN WITNESS WHEREOF, the Parties have caused this Amendment No. 1 to be executed by their undersigned, duly authorized representatives to be effective on the date signed by CPA. This Amendment No. 1 may be executed in one or more counterparts, each of which is an original, and all of which constitute only one agreement between the Parties.
